



### **Vascular Surgery– Academic Surgeon**

The Department of Surgery ([www.surgery.queensu.ca](http://www.surgery.queensu.ca)) at Queen's University is seeking an Academic Vascular Surgeon position specializing in vascular/endovascular surgery. The candidate will have completed vascular fellowship training at the commencement of their appointment or have been practicing vascular/endovascular surgery with an interest in an academic career. Additional fellowship training as a Masters or PhD would also be advantageous. The preferred candidate must have an excellent record of success working in a collaborative multi-disciplinary clinical environment. They must demonstrate strong potential for outstanding educational contributions and significant academic and scholarly research in line with the mission of the Division of Cardiovascular Surgery. Evidence of current involvement and commitment to research through the submission of a research dossier outlining an academic plan and career goals is requested. Applicants will also be involved in undergraduate and post-graduate medical education. Submission of an educational dossier is encouraged.

Qualified applicants will hold an MD degree, have completed an accredited residency program in vascular surgery and received certification in Vascular Surgery. Any postgraduate/fellowship qualifications should be completed prior to appointment. Candidates must be eligible for licensure by the College of Physicians and Surgeons of Ontario and hold certification by the Royal College of Physicians and Surgeons of Canada.

The successful candidate will be a full-time member of the Division of Cardiovascular Surgery and participate in the vascular surgery on-call schedule at Kingston Health Sciences Centre. The successful candidate will also be expected to contribute to the teaching, supervision, and mentorship of undergraduate, graduate, postgraduate students. Endovascular surgical and intervention will be done collaboratively with Interventional Radiology.

Members of the Department of Surgery enjoy an Alternate Funding Program (AFP) compensation package. Academic rank will be commensurate with experience.

Faculty and their dependents are eligible for an extensive benefits package including prescription drug coverage, vision care, dental care, long term disability insurance, life insurance and access to the Employee and Family Assistance Program. Employees also participate in a pension plan. Tuition assistance is available for qualifying employees, their spouses and dependent children. - A cover letter, summarizing expertise, qualifications, and accomplishments relevant to the position. The cover letter should also indicate whether or not you will require a work permit and/or require support with an extension of your work permit in the future.
- Curriculum Vitae
- The names and full contact information of three referees
- A research dossier outlining an academic plan and career goals (required), and an educational dossier highlighting teaching contributions (encouraged)
