EPA 5: Demonstrating the ability to function in the operating room

DETAILED DESCRIPTION

The resident will perform safe and timely preparation for a surgical procedure. Focus will include maintenance of sterility, universal precautions, handling of sharps, understanding occupational risks and hazards and understanding the roles and responsibilities of various operating room personnel. Utilization of the surgical checklist / pre-procedural timeout must be displayed.

ENTRUSTMENT

The resident will be entrusted to:

- 1. Prepare for a basic operative procedure, including a pre-procedural time out and/or safety checklist.
- 2. Employ operating room sterility, including scrubbing, gowning, and maintenance of a sterile operating field.
- 3. Employ safe handling of sharps and maintenance of universal precautions.
